13 chapter 26.50 RCW and will subject a violator to arrest; any assault, drive-by shooting, or
14 reckless endangerment that is a violation of this order is a felony. **You can be arrested**
15 **even if the person protected by this order invites or allows you to violate the order's**
16 **prohibitions.** You have the sole responsibility to avoid or refrain from violating the order's
17 provisions. Only the court can change the order upon written request.

18 **Findings of Fact**

- 19 5. Based upon the record, both written and oral, the court finds that the defendant has been
20 charged with, arrested for, or convicted of a domestic violence offense, that the defendant
21 represents a credible threat to the physical safety of the protected person, and the court
22 issues this Domestic Violence No-Contact Order under chapter 10.99 RCW to prevent
23 possible recurrence of violence.
- 24 6. The court further finds that the defendant's relationship to the person protected by this
