

COMES NOW, Jennine E Christensen, Deputy Prosecuting Attorney for the County of Walla Walla, State of Washington, and by this amended information accuses **FOREST**

**LANE GORDON** of the crime(s) of:

Count 1: Malicious Mischief in the Third Degree - Domestic Violence-Intimate Partner, RCW 9A.48.090(1)(a) and 26.50.010(7), Class Gross Misdemeanor (364 days or fine of \$5,000 or both);

Count 2: ~~Unlawful Carrying Or Handling Of A Weapon~~, RCW 9A.12.030(1), Class GM Gross Misdemeanor (364 days or fine of \$5,000 or both);

*Aiming or Discharging a Firearm*

committed as follows:
